Sub: Issue of Certificate of Recognition to the Schools under Sub-rules (4) of rule-13 of the Odisha Right of Children to Free and Compulsory Education Rules.2010 and under Section 18 of Right of Children to fee and Compulsory Education Act-2009

Dear Sir/ Madam,

With reference to your on-line application nos mentioned against your school name (list of 11 schools enclosed) subsequent correspondence with the school/ inspection in this regard, I convey the grant for issuance of Certificate of Recognition to the (name of the eleven schools with address list enclosed) for Classes mentioned in the list attached for period of five years w.e.f. dt.01.04.2021 to dtd 31.03.2026.

The above sanction is subject to fulfilment of following conditions:-

1. The Grant of recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class-VIII
2. The School shall abide by the provisions of Right to children to free and Compulsory Education Act, 2009 and the Odisha Right to Children to free and compulsory Education Rule 2010.
3. The School shall admit in Class-I, to the extent of 25% of the strength of that Class, Children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion, provided, further that in case of pre-primary classes also, this norm shall be followed.
4. For the Children referred to in paragraph-3, the school be reimbursed as per Section 12(2) of the Act. To receive such reimbursements schools shall provide a separate bank account.
5. The Society/School shall not collect any capitation fee and subject the child of his on her parents or guardians to any screening procedure.

6. The School shall not deny admission to any child for back of age proof. If such admission is sought subsequent to the extended provided prescribed for admission. On the ground of religion, case or race, place of birth or any of them.
7. The School shall ensure:
 - (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school
 - (ii) No child shall be subjected to physical punishment or mental harassment.
 - (iii) No child is required to pass any board examination till the completion of elementary education.
 - (iv) Every Child completing elementary education shall be awarded a certificate as laid down under Rule-22
 - (v) Inclusion of Students with disabilities/ Special needs as per provisions of the act.
 - (vi) The Teachers are recruited with minimum qualification as laid under section-23(1) of the act.
 - (vii) The teacher performs its duties specified under Section 24(1) of the act and
 - (viii) The teachers shall not engage themselves for private teaching activities.
8. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
9. The School shall enrol students proportionate to the facilities available in the school as prescribed in the section 19 of the act.
10. The School shall maintain the standards and norms of the schools as specified in section 19 of the act. the facilities reported as the time of last inspection are as given under:-
 - Area of School campus
 - Total built up area
 - Area of pay ground
 - No. of class rooms
 - Room for Headmaster-Cum-Office-Cum-store room
 - Separate toilets for boys and girls
 - Drinking water facility
 - Kitchen for cooking Mid Day Meal
 - Barrier free access
 - Availability of teaching learning Material/Play sport Equipments/Library
 - Implementation of School Safety policy
 - Fire safety measures
11. No un recognised classed shall run within the premises of the school or outside in the same name of School.
12. The School Building or other structures or the grounds are used only for the purpose education and skill development.
13. The School is run by a society registered under the societies Registration Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.
14. The School is not run for profit to any individual, group or association of individuals or by other persons.
15. The account should be audited and certified by a chartered Accountant and proper accounts statement should be prepared as per rules. A copy each of statements of Accounts statements should be prepared as per rules.
16. The recognition code number allotted to your School is mentioned in the list attached. This may please be noted and quoted for any correspondence with this office.

17. The School furnishes such reports and information as may be required by the Director, Elementary Education/District Education Officer/Block Education Officer as the case may be issued to secure the continued fulfilment of condition of recognition of removal of deficiencies in working of the Schools.
18. Renewal of Registration of Society if any be ensured.


